- ► (45%) of currently married women age 15-59 and almost threequarters of currently married men age 15-59
- (73%) were employed at any time during the past 12 months.
- Among those employed higher proportions of women (11%) than men (7%) are not paid for their work.
- ► Employed men are slightly more likely to be paid in cash only (85%) than employed women (79%).
- Similar proportions of employed women (5%) and men (4%) are paid with a mix of cash and in-kind compensation



Latest developments in women property rights legislation

- Civil Code 1929 articles 1631–1371 provided the first 2 institutes:
- "Dota" property that the wife of third persons on her behalf would give to the husband as a title to bear the costs of marriage (trans.pasuria, të cilën gruaja ose persona të tjerë për llogari të saj ia sillnin burrit shprehimisht me tituli dote për të mbajtur barrët e martesës)
- "parafernale property" property that is on the sole wonership and rights of the wife. Pasuria parafermale është pasuria e gruas që nuk përfshihet në dotë dhe që bashkëshorti nuk ka të drejtë ta administrojë dhe as të kërkojë kreditë e saj nëqoftëse nuk ka porosi nga bashkëshortja.
- Law no. 9209, dated 23.03.2004 "on the legalization of the constructions addendum"
- Law no. 9304, dated 23.10.2004 "on the legalization and urban planning of informal aereas".
- Law no. 33/2012 "on the registration of the reale estate" Art 41, "co-ownership rights"
